- **GENERAL DESCRIPTION:** According to the Judith Basin County Court House records, 227 +/- acres are tillable. The remaining 90 +/- acres are in native grasses, and these acres lie in 2 coulees. A small reservoir lies at the east end of the larger coulee. No buildings are on the property. The grass acres are partially fenced. The property is currently leased and the 2019 crop is not included in the sale. Current lease expires at the end of this crop year. All 2019 FSA Farm Program payments remain the property of the current operator. A non-income generating communications tower is located near the very southern border of the property and consists of less than 0.5 acre of land. An right-of-way easement is in place for land use and access to the tower as well as access to a nearby state gravel pit.
