

RELEASE OF LIABILITY & INDEMNITY AGREEMENT FORM All Exhibitors Must Sign Before Entry Becomes Valid

As valid consideration for entry into and participation in activities (the "Activities") _____ (*exhibitor name*), the undersigned hereby enter into this RELEASE OF LIABILITY AND INDEMNITY AGREEMENT (this "Agreement").

1. Right to Refuse Entry: Herb and Beth Schnitker reserve the right to refuse entry to any Exhibitor, Contestant, or other person.

2. Acknowledgment of Risks: The undersigned recognize and understand there are risks associated with entry into and participation in the Activities including, but not limited to, bodily injury or death, and damage to property or privacy rights. The undersigned further acknowledge that they will be liable for all damage to persons, livestock, or property that is caused by them or any persons (including, but not limited to, minors) under their care and control, and that arise out of, or are related to, the undersigned's entry into and participation in the Activities. A LIVESTOCK SHOW SPONSOR IS NOT LIABLE FOR AN INJURY TO OR THE DEATH OF A PARTICIPANT IN A LIVESTOCK SHOW RESULTING FROM THE INHERENT RISKS OF LIVESTOCK SHOW ACTIVITIES.

3. Release from Liability: The undersigned hereby RELEASE, ACQUIT AND FOREVER DISCHARGE AND AGREE TO DEFEND, INDEMNIFY AND HOLD HARMLESS Herb and Beth Schnitker, and Dick and Joyce Piliard, its present and former directors, officers, employees, agents and representatives and the respective heirs, administrators, executors, successors, and assigns and any other person, firm, or corporation from any and all claims, causes of action, suits and/or demands for personal injury, death or property damage, accrued or to accrue in the future, known or unknown, (collectively, "Claims") relating to or arising out of any negligent, grossly negligent and/or intentional or unintentional acts on the part of the undersigned in connection with entry into and participation in the Activities. Without limiting the foregoing, the undersigned agree that Herb and Beth Schnitker, and Dick and Joyce Piliard or Parties shall not be liable to them, their family, heirs, administrators, executors, or assigns for Claims arising from or related to the undersigned Exhibitor's entry into and participation in the Activities.

4. Agreement to Indemnify and Hold Harmless: THE UNDERSIGNED AGREE TO RELEASE, ACQUIT AND FOREVER DISCHARGE AND SHALL DEFEND, INDEMNIFY AND HOLD HARMLESS Herb and Beth Schnitker, and Dick and Joyce Piliard PARTIES AGAINST THE CONSEQUENCES OF _____ (*exhibitor name*) ACTIONS, REGARDLESS OF WHETHER SUCH ACTION WAS THE SOLE, PROXIMATE OR PRODUCING CAUSE OF THE CLAIMS; provided, however, that the duty of the undersigned to defend, indemnify and hold harmless Herb and Beth Schnitker, and Dick and Joyce Piliard shall extend only to Claims arising directly or indirectly from the undersigned Exhibitor's entry into and participation in the Activities. As used herein, "INDEMNIFY" means to agree to exempt from liability in a situation, thereby relieving them of responsibility and/or reimbursing Herb and Beth Schnitker, and Dick and Joyce Piliard for Claims asserted against them.

5. By participating in show you voluntarily assume all risks related to exposure to COVID-19 and agree to follow guidelines set forth by the federal government and State of Missouri.
