Bid Acceptance: The real estate is being offered with reserve and is subject to seller confirmation of the winning high bid. Winning bidder will complete and sign the Real Estate Purchase Contract immediately upon conclusion of the online auction event.

The Earnest Money Deposit is payable personal check, business check or bank wire to the title company.
