PERFORMED SYSTEM INSPECTION ON 1 PACKAGED HEATPUMP. CHECKED ALL COOLING, ELECTRICAL AND MECHANICAL COMPONENTS. ALL COMPONENTS ARE WORKING WITHIN MANUFACTURERS SPECIFICATIONS AT THIS TIME. SYSTEM IS COOLING WITH A 28 DEGREE TEMPERATURE DIFFERENTIAL AT THIS TIME. SYSTEM IS A GOETTL OF UNDETERMINED AGE BUT PRETTY OLD. THE COMPRESSOR AND CONDENSER FAN MOTOR HAVE BEEN REPLACED RECENTLY WITH AFTERMARKET PARTS. COMPRESSOR IS NOT BOLTED TO THE CABINET DUE TO BEING AN AFTERMARKET PART AND THE MOUNTING HOLES DO NOT LINE UP. BLOWER MOTOR CAPACITOR IS LEAKING FLUID AND IS VERY WEAK, SHOUD BE REPLACED. THERE IS MINOR RUSTING ON THE EVAPORATOR COIL, BUT THIS IS CONSISTENT WITH THE AGE OF THE SYSTEM. REFRIGERANT LEVEL MEETS MANUFACTURERS SPECIFICATIONS. NO VISIBLE SIGNS OF LEAKS. SYSTEM IS COOLING PROPERLY AT THIS TIME.
