WHEREAS, the above-described real estate lies adjacent to each other; and

WHEREAS, GRANTEE desires to install field tiling in GRANTEE'S property for the removal of water therefrom; and

WHEREAS, the best outlet for the water carried away by said field tiling is located on the other side of GRANTOR'S property and the best access to that outlet is by going through and under GRANTOR'S property; and

WHEREAS, the parties desire to set out in writing their agreement concerning the same, and to mention their respective

rights and responsibilities relating to such easement.

(\$1.00,) and other good and valuable consideration, the receipt whereof is hereby acknowledged, GRANTOR does hereby grant, bargain, sell and convey to GRANTEE an easement over, upon, through and under the aforesaid GRANTOR'S property for the purpose of installing field tile at a minimum depth of <a href="three">three</a> feet in said land. Such field tile shall be (perforated or non-perforated) tile. Such field tile shall follow the paths shown on the accompanying Exhibit A which is made a part of this agreement.

GRANTOR does further hereby grant, bargain, sell and convey to GRANTEE a temporary construction easement over, through and upon GRANTOR'S aforesaid property for the purpose of installing such field tile. This temporary construction easement shall terminate on the 31 day of December, 1988.

GRANTOR does further hereby grant, bargain, sell and convey to GRANTEE a perpetual easement for the purpose of inspecting and repairing said field tile. GRANTEE agrees to pay GRANTOR for any damages that the GRANTEE may cause through his repair of the field tile. The amount of damages shall be determined by a person mutually selected by GRANTOR and GRANTEE. If GRANTOR and GRANTEE cannot agree on such a person, GRANTOR and GRANTEE shall each select a person and those two persons shall select a third person. Those three persons shall then conclusively determine the amount of such damages, which GRANTEE does agree to pay within ten days of the determination of the amount.

GRANTEE shall bear all construction costs for the installation of GRANTEE'S tiling over GRANTOR'S land.

GRANTEE does promise that all tiling shall be correctly and professionally done so as not to cause any difficulties to GRANTOR after installation.

These easements and covenants shall run with the land and inure to the benefit of and be binding upon the successors in title of the respective parties.
