SERVICED 2 SPLIT SYATEM HEAT PUMPP UNITS AND FOUND BOTH COMPRESSORS ARE PULLING TOO HIGH AMPERAGE AT START UP, INSTALLING A HARD START KIT INTO EACH CONDENSER WILL ASSIST WITH TTHE START UP AND HELP THE COMPRESSOR TO LAST LONGER. I ALSO FOUND ON THE EAST UNIT INDOOR BLOWER MOTOR TO SHOW BEARING PLAY AND APPROACHING MAXIMUM AMPERAGE. THE EAST UNIT CONDENSER ALSO SHOWED A DUAL 45/5 CAPACITOR THAT HAS LOW READINGS. NOTHING REPAIRED AT THIS TIME. ESTIMATE SENT FOR REPAIRS.
