

## AMENDMENT TO THE PROTECTIVE COVENANTS OF HIDDEN SPRING SUBDIVISION

The undersigned owners of parcels in Hidden Spring Subdivision, Delta County, Colorado hereby amend those Protective Covenants Recorded November 1, 1999 in Book 843 at Page 69 under Reception #529619.

An Amended Plat of said Hidden Spring Subdivision was recorded January 5, 2000 under Reception #531288.

Said Covenants shall have the following amendment:

Paragraph 5 shall be replaced with the following: "5. HOMES. If mobile, modular, or manufactured homes are allowed and approved by the Architectural Control Committee (as discussed in Paragraph 6), they must still meet the following conditions: Must have a year of manufacture or Construction of 1995 or newer; must be placed on a permanent foundation (concrete footings below frost line, tongue and axles removed, title purged, and be skirted); and must be wood sided with an exterior finish of a local, natural wood color so as to blend in with the surrounding natural environment. (The existing home on Parcel 1, Hidden Spring Subdivision shall be 'grandfathered-in' and exempted from the changes made in this amendment to the covenants)."
