- D. Documents satisfactory to us creating the interest in the land and/or mortgage to be insured must be signed, delivered and recorded.

NOTICE OF REQUIREMENT - WIRE TRANSFER OF CLOSING FUNDS

Effective July 1, 2009 Indiana law prohibits disbursement of closings unless all necessary funds required are wire transferred to the settlement agent's escrow account. (see I.C. 27-7-3.7) The law applies to all parties including lenders, buyers, sellers and real estate professionals. The Company must be furnished a Certificate of Trust or a copy of the Trust documents which designate the trustee and confer upon the trustee the power to act in the pending transaction, together with copies of any amendments, modifications, or revocations. The Company will require a Statement from the Trustee that the Trust has not been amended or modified, except as heretofore disclosed, and that the Trust is still in full force and effect. At the time the Company is furnished these items, the Company may make additional requirements or exceptions.
- E. Payment of \$5 Title Insurance Enforcement Fund fee required by IC 27-7-3 for each policy issued in connection with the transaction.

7. Any liens, encumbrances, requirements and other matters shown in Schedule B – I and not released or otherwise disposed of to our satisfaction.
8. Minerals or mineral rights or any other subsurface substances (including, without limitation, oil, gas and coal), and all rights incident thereto, now or previously leased, granted, excepted or reserved.
9. Terms and conditions of the easement(s) insured on Schedule A.
10. Rights of Way for drainage ditches, tiles, feeders and laterals, if any.
11. Rights of the Public and the State of Indiana and to that part of the premises taken or used for alley or road purposes, including utility rights of way.
