3 **Lead Warning Statement:** Every Buyer of any interest in residential real property on which a residential dwelling was built prior to
4 1978 is notified that such property may present exposure to lead from lead-based paint that may place young children at risk of
5 developing lead poisoning. Lead poisoning in young children may produce permanent neurological damage, including learning
