

## **SURVEYOR'S REPORT**

SUBJECT PROPERTY: This survey was done at the request of Gene Merkley of Southern Indiana Hardwoods to perform an original survey of two tracts in Section 31, Township 6 South, Range 1 West in Tobin Township, Perry County, Indiana. The record owner is Southern Indiana Hardwoods with a deed of record found in Instrument #2002R-14047.

In accordance with Title 865, Article 1.1. Chapter 12, Sections 1 through 34 of the Indiana Administrative Code, the following observations and opinions are submitted regarding the various uncertainties in the locations of the lines and corners established this survey as a result of:

**VARIANCES** in the reference monuments:

## Reference monuments and corners from this and previous surveys

West ¼ of Section 31, T6S, R1W: Recovered a stone referenced by a Carsonite marker. North 1/16 of Section 31, T6S, R1W: Recovered a stone referenced by a Carsonite marker. South 1/16 of Section 31, T6S, R1W: Recovered a stone referenced by a Carsonite marker.

**SE 1/16 of Section 31, T6S, R1W:** 5/8" rebar set by this firm on Job #03-031.

CW 1/16 of Section 31, T6S, R1W: 5/8" rebar set by this firm on Job #03-031. Center 1/4 of Section 31, T6S, R1W: 5/8" rebar set by this firm on Job #03-031.

**CE 1/16 of Section 31, T6S, R1W:** 5/8" Smith rebar.

East 1/16 of Section 31, T6S, R1W: Recovered a metal government disk.

**RANDOM ERRORS** in measurement: This is considered to be a rural survey with an acceptable relative positional accuracy of 0.26 plus 200 parts per million.

**THEORY OF LOCATION:** The section, and quarter lines were established from monuments recovered in the field and ties to Job #03-031 by this firm. The new property lines and the easements were set as per the client's request.
