Sinking room is not due to a leak in domestic plumbing. There is no sewer plumbing in this area either. Traced out sewer from street and found sewer enters into home between garage door and window in middle of home. There are no sewer clean outs to perform a sewer static test and if this is needed, clean outs will need to be installed. I do not know if there is a sewer issue but sewer is not in area of shifting. Homeowner is aware and will consider whether or not to do sewer testing. Cracks have been present in walls of home for years as well as the stain on ceiling in shifting room. Roof leak was fixed years ago for this stain and it doesn't get water in home any longer.
