DEED OF AGREEMENT FOR COMMON EASEMENT

This indenture and agreement made this 4 ± 4 day of August, 1980, between JAMES STANDARD, OLIN W. INCE and JAMES K. BLAKE, the owners of certain Subleases of a leasehold estate covering all that certain lot, pracel or tract of land in Brown County, Texas, being out of the John B. Foreman Survey No. 61, Abstract No. 323, and also being Lot No. 5 of Rolling Hills Estates No. 2 as filed in the Plat Records of Brown County, Texas, to which Plat Records reference is here made for all purposes, have mutually concluded and agreed with each other, for a valuable consideration, that a common roadway as it presently exists on the ground on Lot No. 5 described above shall be left open and each of the parties signatory hereto shall have the right to utilize said existing roadway for a passageway to and from their respective portions of said Lot No. 5 and the said parties to these presents, for themselves, respectively, and their respective heirs and assigns, do, and each of them does, covenant and agree to and with the other of them, the said parties hereto and their heirs and assigns, that said existing roadway extending into and across Lot No. 5 shall at all times hereafter be and remain open as and for a passageway for the mutual use and accomodation of all of the said owners of said leasehold estates on Lot No. 5 hereinbefore described and of the respective occupants of the same and said easement and rightof-way shall run with the land and the leasehold estates relating and pertaining thereto.
