North 53°17'14" West, 470.00 feet to a concrete highway monument found;

North 03°22'55" West, 206.06 feet to a 5/8" steel rod found for the Northwest corner of said 65.05 acres and Northeast corner of said 3.0 acres at the intersection of the East line of State Highway No. 204 with the South line of U. S. Highway No. 84 and in the South line of that 8.7 acres from Homer Rawlinson et ux to State of Texas on August 18, 1932 in 224/362, DR;

North 75°21'00" East, 250.07 feet to a 5/8" steel rod found;

North 53°29'43" East, 107.78 feet to a 5/8" steel rod found; North 75°18'47" East, at 300.83 feet pass a concrete highway monument found on line, continuing in all 397.02 feet to a ½" steel rod w/cap set for the Northeast corner of this tract and the Northwest corner of 10.00 acres, this day created (hereinafter shown as Tract Two);

3.0 acres as follows:

North 04°20'11" West, 95.60 feet to a 5/8" steel rod found;

North 53°13'23" West, 99.85 feet to a 5/8" steel rod found;

South 36°44'42" West, 150.02 feet to the PLACE OF BEGINNING, and containing within these calls, 14.54 acres of land.
