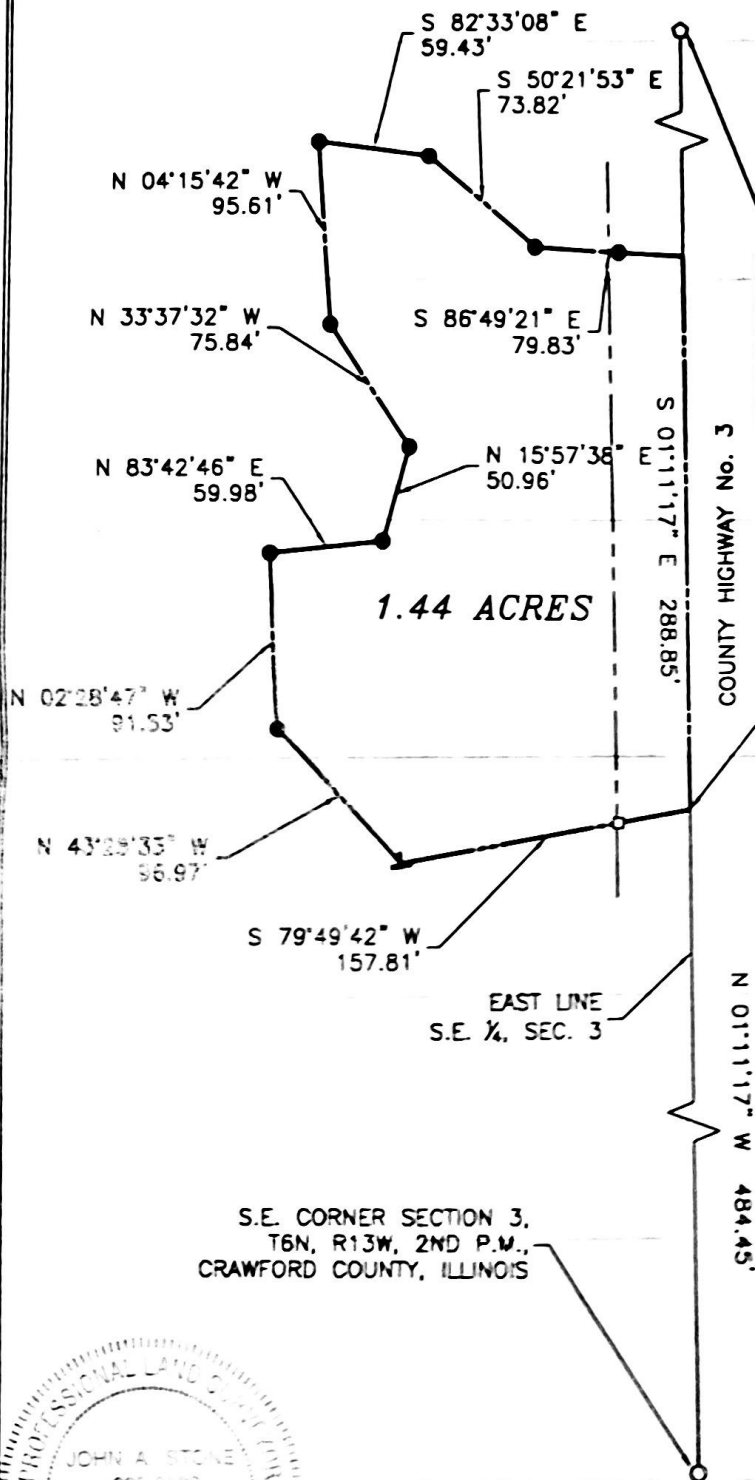

SURVEYOR'S DESCRIPTION

A part of the South Half of the Southeast Quarter of Section 3, Township Six North, Range Thirteen West of the Second Principal Meridian, Crawford County, Illinois, described as follows:

Commencing at the Southeast corner of Section 3; thence North 01° 11' 17" West along the East line of said Southeast Quarter, 484.45 feet to the point of beginning; thence South 79° 49' 42" West, 157.81 feet to a T-post; thence North 43° 28' 33" West, 96.97 feet to an iron pin set; thence North 02° 28' 47" West, 91.53 feet to an iron pin set; thence North 83° 42' 46" East, 59.98 feet to an iron pin set; thence North 15° 57' 38" East, 50.96 feet to an iron pin set; thence North 33° 37' 32" West, 75.84 feet to an iron pin set; thence North 04° 15' 42" West, 95.61 feet to an iron pin set; thence South 82° 33' 08" East, 59.43 feet to an iron pin set; thence South 50° 21' 53" East, 73.82 feet to an iron pin set; thence South 86° 49' 21" East, 79.83 feet to the said East line of said Southeast Quarter; thence South 01° 11' 17" East along said East line, 288.85 feet to the point of beginning.

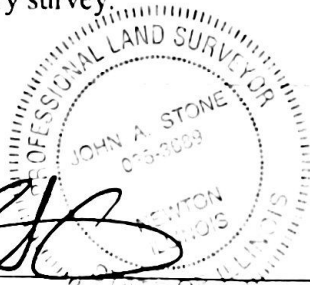
