FIELD NOTES OF 0.233 ACRE OF LAND

Being 0.233 acre of land situated in the Reuben Cole Survey, A-153, Harrison County, Texas and being out of the central part of that certain tract, called 0.966 acre, described in deed from Amber Powell to Chads Carpet Care, LLC recorded in Document No. (Doc. No.) 2021-000013869, in the Office of the County, Clerk, Harrison County, Texas (OCCHCT) and being more particularly described as follows:

BEGINNING at a capped (RPLS 4445) 3/8" steel rebar set in the south right-of-way (ROW) line of State Highway 154 (SH 154), in a curve to the right having a radius of 1382.39 feet, from which a capped (RPLS 4606) 1/2" steel rebar found in said ROW line for the NE Corner of the 0.966 acre tract bears S 71 deg 47' 52" E, along a chord, 146.77 feet;

THENCE: S 18 deg 09' 46" W, across said 0.966 acre tract, 141.44 feet, to a capped (RPLS 4445) 3/8" steel rebar set in the south line of the 0.966 acre tract, same being the lower northeast line of the Marlene Whitehead Wendel 4.35 acres tract (Deed Reference: Doc. No. 2019-000014267, OCCHCT) and being N 54 deg 32' 04" W, 115.45 feet, from a capped (RPLS 4606) 1/2" steel rebar found for the SE Corner of the 0.966 acre tract, same being an interior ell corner of the 4.35 acres tract;

THENCE: N 54 deg 32' 04" W, with said south line of the 0.966 acre tract, 96.37 feet, to a capped (RPLS 4445) 3/8" steel rebar set for the SW Corner of this tract, from which a 1/2" steel rebar found in the south ROW line of SH 154 for the westernmost corner of the 0.966 acre tract bears N 54 deg 32' 04" W, 187.58 feet;


THENCE: N 30 deg 32' 59" E, across the 0.966 acre tract, 110.04 feet, to a capped (RPLS 4445) 3/8" steel rebar set in said curved south ROW line of SH 154 for the NW Corner of this tract and being S 80 deg 04' 27" E, 115.26 feet, along a chord, from a capped (RPLS 4606) 1/2" steel rebar found for angle point in said ROW line at a point which is 50 feet right of Highway Centerline Station 1311+00;

THENCE: With said ROW line, along a curve to the right, having a radius of 1382.39 feet, an arc length of 68.62 feet, and a chord which bears S 76 deg 15' 46" E, 68.61 feet, to the POINT OF BEGINNING and containing 0.233 acre of land.
