AN ORDINANCE OF THE CITY OF JEFFERSON, MISSOURI, CHANGING, AMENDING, AND MODIFYING THE ZONING MAP OF THE ZONING CODE OF THE CITY OF JEFFERSON, BY REZONING THE NORTHEASTERLY 34.3 ACRES OF THE SCHOTTHILL WOODS SUBDIVISION FROM RA-2 (MULTI-FAMILY RESIDENTIAL) TO PUD (PLANNED UNIT DEVELOPMENT).

WHEREAS, IT APPEARS THAT THE PROCEDURES SET FORTH IN THE ZONING CODE RELATING TO ZONING HAVE IN ALL MATTERS BEEN COMPLIED WITH,

Part of the Northeast Quarter of the Southwest Quarter, part of the Southeast Quarter of the Northwest Quarter, and part of the North Half of the Southeast Quarter, all in Section 21, Township 44 North, Range 11 West, in the City of Jefferson, County of Cole, Missouri; being more particularly described as follows:
