

## LAND DESCRIPTIONS

## TRACT 1


A PART OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER (SW/4 SE/4) AND PART OF THE SOUTHEAST QUARTER OF THE SOUTHEAST QUARTER (SE/4 SE/4) OF SECTION EIGHT (08), TOWNSHIP SIXTEEN (16) NORTH, RANGE SEVENTEEN (17) WEST OF THE FIFTH PRINCIPAL MERIDIAN, SEARCY COUNTY, ARKANSAS AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE COMPUTED NORTHWEST CORNER OF THE SW/4 SE/4 OF SAID SECTION 08, SAID POINT ALSO BEING THE POINT OF BEGINNING OF TRACT BEING DESCRIBED, THENCE SOUTH 88° 12' 56" EAST (BEARINGS BASED ON GRID NORTH NAD 83) 1280.46 FEET (DISTANCES ARE GROUND DISTANCE) TO AN EXISTING ONE-HALF INCH REBAR WITH ID CAP #1769 MARKING THE NORTHWEST CORNER OF THE SE/4 SE/4 OF SAID SECTION 08, THENCE SOUTH 88° 12' 56" EAST 1320.09 FEET TO AN EXISTING ONE-HALF INCH REBAR WITH ID CAP #1769 MARKING THE NORTHEAST CORNER OF SAID SE/4 SE/4, THENCE ALONG THE EAST LINE OF SAID SE/4 SE/4 SOUTH 01° 38' 36" WEST 155.59 FEET TO AN EXISTING ONE-HALF INCH REBAR WITH ID CAP #1769, THENCE LEAVING SAID EAST LINE NORTH 88° 21' 24" WEST 527.88 FEET TO AN EXISTING THREE-EIGHTHS INCH REBAR, THENCE SOUTH 78° 29' 31" WEST 384.41 FEET TO AN EXISTING THREE-EIGHTHS INCH REBAR, THENCE SOUTH 73° 01' 49" WEST CROSSING AN EXISTING THREE-EIGHTHS INCH REBAR ON THE WEST LINE OF SAID SE/4 SE/4 AT 440.36 FEET, IN ALL 680.33 FEET TO AN EXISTING THREE-EIGHTHS INCH REBAR. THENCE SOUTH 36° 30' 34" WEST 677.94 FEET TO AN EXISTING ONE-HALF INCH REBAR WITH ID CAP #1769. THENCE NORTH 34° 05' 34" WEST 10.41 FEET TO A POINT IN THE CENTERLINE OF TALL ROCK ROAD, THENCE ALONG SAID CENTERLINE THE FOLLOWING COURSES: SOUTH 65° 11' 28" WEST 124.53 FEET, SOUTH 73° 06' 43" WEST 34.26 FEET, SOUTH 82° 44' 37" WEST 41.50 FEET, SOUTH 84° 49' 00" WEST 68.25 FEET, SOUTH 78° 41' 01" WEST 39.97 FEET, SOUTH 75° 40' 19" WEST 54.99 FEET, SOUTH 81° 46' 32" WEST 48.03 FEET, NORTH 87° 21' 57" WEST 47.12 FEET, NORTH 72° 58' 48" WEST 62.32 FEET, NORTH 83° 44' 05" WEST 27.59 FEET TO A POINT IN THE CENTERLINE OF A SPRING BRANCH, THENCE LEAVING SAID CENTERLINE OF TALL ROCK ROAD AND ALONG SAID CENTERLINE OF A SPRING BRANCH THE FOLLOWING COURSES: NORTH 10° 17' 19" WEST 5.99 FEET. NORTH 02° 16' 53" WEST 15.78 FEET. NORTH 75° 17' 05" EAST 10.12 FEET TO A POINT. SAID POINT BEING THE CENTER OF A CONCRETE SPRING BOX, THENCE NORTH 88° 26' 31" WEST 133.09 FEET TO A POINT ON THE WEST LINE OF SAID SW/4 SE/4, THENCE ALONG SAID WEST LINE NORTH 01° 14' 15" EAST 1083.82 FEET TO THE POINT OF BEGINNING, CONTAINING 32.02 ACRES AGGREGATE, MORE OR LESS, SUBJECT TO THE RIGHT OF WAYS OF US HIGHWAY 65 AND TALL ROCK ROAD.

## TRACT 2

A PART OF THE SOUTHWEST QUARTER OF THE SOUTHEAST QUARTER (SW/4 SE/4) OF SECTION EIGHT (08), TOWNSHIP SIXTEEN (16) NORTH, RANGE SEVENTEEN (17) WEST OF THE FIFTH PRINCIPAL MERIDIAN, SEARCY COUNTY, ARKANSAS AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT THE COMPUTED SOUTHEAST CORNER OF THE SW/4 SE/4 OF SAID SECTION 08, THENCE ALONG THE SOUTH LINE OF SAID SW/4 SE/4 NORTH 88° 26' 31" WEST (BEARINGS BASED ON GRID NORTH NAD 83) 686.06 FEET (DISTANCES ARE GROUND DISTANCE) TO AN EXISTING ONE-HALF INCH REBAR WITH ID CAP #1769, SAID POINT ALSO BEING THE POINT OF BEGINNING OF TRACT BEING DESCRIBED, THENCE CONTINUING ALONG SAID SOUTH LINE NORTH 88° 26' 31" WEST 484.44 FEET TO A POINT IN THE CENTERLINE OF A SPRING BRANCH, THENCE LEAVING SAID SOUTH LINE AND ALONG SAID CENTERLINE THE FOLLOWING COURSES: NORTH 25° 49' 40" EAST 39.44 FEET, NORTH 16° 42' 32" EAST 27.55 FEET, NORTH 01° 40' 46" EAST 127.45 FEET, NORTH 10° 17' 19" WEST 9.08 FEET TO A POINT IN THE CENTERLINE OF TALL ROCK ROAD, THENCE LEAVING SAID CENTERLINE OF A SPRING BRANCH AND ALONG SAID CENTERLINE OF TALL ROCK ROAD THE FOLLOWING COURSES: SOUTH 83° 44' 05" EAST 27.59 FEET, SOUTH 72° 58' 48" EAST 62.32 FEET, SOUTH 87° 21' 57" EAST 47.12 FEET, NORTH 81° 46' 32" EAST 48.03 FEET, NORTH 75° 40' 19" EAST 54.99 FEET, NORTH 78° 41' 01" EAST 39.97 FEET, NORTH 84° 49' 00" EAST 68.25 FEET, NORTH 82° 44' 37" EAST 41.50 FEET, NORTH 73° 06' 43" EAST 34.26 FEET, NORTH 65° 11' 28" EAST 124.53 FEET TO A POINT, THENCE LEAVING SAID CENTERLINE SOUTH 34° 05' 34" EAST 10.41 FEET TO AN EXISTING ONE-HALF INCH REBAR WITH ID CAP #1769, THENCE SOUTH 34° 05' 34" EAST 72.51 FEET TO AN EXISTING ONE-HALF INCH REBAR WITH ID CAP #1769, THENCE SOUTH 28° 10' 26" WEST 250.97 FEET TO THE POINT OF BEGINNING, CONTAINING 2.60 ACRES, MORE OR LESS. SUBJECT TO THE RIGHT OF WAY OF TALL ROCK ROAD.
