

COMMERCIAL LEAD-BASED PAINT DISCLOSURE

Federal law mandates that Sellers of housing constructed prior to 1978 must complete certain Lead-Based Paint
Disclosure requirements. These should be completed before the Buyer makes an offer and certainly before the
Seller accepts a purchase offer, otherwise the Buyer may not be obligated under any contract to purchase such
housing.

5 Lead Warning Statement

Every purchaser of any interest in residential real property on which a residential dwelling was built prior to 1978 6 7 is notified that such property may present exposure to lead from lead-based paint that may place young children at 8 risk of developing lead poisoning. Lead poisoning in young children may produce permanent neurological damage, 9 including learning disabilities, reduced intelligence quotient, behavioral problems, and impaired memory. Lead poisoning also poses a particular risk to pregnant women. The Seller of any interest in residential real property is 10 required to provide the Buyer with any information on lead-based paint hazards from risk assessments or inspections 11 12 in the Seller's possession and notify the Buyer of any known lead-based paint hazards. A risk assessment or inspection for possible lead-based paint hazards is recommended prior to purchase. 13

15 Seller Disclosure

If no reports or records are available, Seller shall indicate as such.
