South 66°02'02" West, 60.49 feet to a point in said road for the most Southerly Southwest corner of said 20.34 acres and the most Easterly Northeast corner of that Tract 1 called 131.451 acres in DN 2019000118, DR, same being in a projection of the old Logansport Road;
