

This improvement permit shall be valid upon a showing to the Department that the site and soil conditions are unaltered, that the facility, design wastewater flow, and wastewater characteristics are not increased, and that a wastewater system can be installed that meets the permitting requirements in effect on the date the improvement permit was issued. Improvement permits for which a plat is provided shall be valid without expiration. Improvement permits for which a site plan is provided shall be valid for five years. This permit is subject to revocation if the site plan or plat, whichever is applicable, or the intended use changes.

The health department shall issue an authorization to construct prior to the installation or repair of wastewater system when it has determined after a field investigation that the system can be installed and operated in compliance with Article 11 of Chapter 130A of the general statutes of NC and Rules adopted pursuant to this Article. It will be valid for a period equal to the period of validity of the improvement permit, not to exceed five years.
