Dear Mr. Pearson:

Petroleum releases were identified at the referenced site when the underground storage tank system was removed on September 24, 2014. Up to 12,000 mg/kg gasoline-range Total Petroleum Hydrocarbons (TPH) were detected beneath the 2,000-gallon kerosene tank; 19,000 mg/kg diesel-range TPH was detected beneath the kerosene dispenser; and 3,100 diesel-range TPH was detected below the diesel dispenser. The site was recommended to the State Lead Cleanup Program in February 2020, and we have completed our assessment.

On January 29, 2021, the UST Section of the Division of Waste Management, Trust Fund Branch received an Initial Monitoring Report for the site. In December 2020, monitor wells were installed in each source area to collect groundwater and soil samples. No petroleum contaminated groundwater was detected above the level of the standards or interim standards established in 15A NCAC 2L .0202. In addition, no targeted compounds were detected in the soil above their respective Maximum Soil Contaminant Concentrations.

Based on information provided to date, the UST Section finds it appropriate to classify the risk of the discharge or release as low. Furthermore, the UST Section determines that no further action is warranted for this incident. This determination shall apply unless the UST Section later finds that this discharge or release poses an unacceptable risk or a potential risk to human health or environment, or additional information is provided to warrant reassessment of the site.
