## WARRANTY DEED

KNOW ALL MEN BY THESE PRESENTS:

That we, William R. Jordan, Jr., a single person, and Castle W. Jordan and Jean P. Jordan, his wife, for and in consideration of the sum of One (\$1.00) Dollar and other good and valuable consideration, to us in hand paid by Hurricane Creek Ranch, Inc., an Arkansas Corporation, the receipt whereof is hereby acknowledged, do hereby grant, bargain, sell and convey unto the said Hurricane Creek Ranch, Inc., an Arkansas Corporation, and unto its successors and assigns forever, the following lands lying in the County of Sharp and State of Arkansas, to-wit:

The West Half of the Southwest Quarter and the Southeast Quarter of the Southwest Quarter of Section 7 and the Northwest Quarter of the Northwest Quarter of Section 18 in Township 17 North, Range 4 West. And the Northwest Quarter of the Southeast Quarter; and the East Half of the Southeast Quarter of Section 12 in Township 17 North, Range 5 West. And the North Half of the Southeast Quarter and the Northeast Quarter of the Northeast Quarter of Section 13 in Township 17 North of the Base Line and Range 5 West of the 5th P.M. And the South Half of the Southeast Quarter of Section 7; the Northwest Quarter of the Northeast Quarter; and the Northeast Quarter of the Northwest Quarter of Section 18; all in Township 17 North of the Base Line and Range 4 West of the Fifth Principal Meridian.
