

J. Singleton Survey, Abstract No. 787, being all of that certain Tract I - 327.976 acres, and all of that certain Tract II - 200 acres, said tracts being described in a Deed from JBL Properties, LLC, to Joe Nichols, Trustee, filed December 07, 2023, recorded in Document No. 2023-02274, Official Public Records of said County, and bounded as follows:

Beginning at a 2 1/2 inch diameter iron pipe fence corner post found on the Northernmost NWC of said 200 acre tract, same being on the NEC of a 10.109 acre tract described in a Deed from Paula Kaye Hall, et al, to John Timothy Horton and Rebecca Luellen Cavasher, filed August 29, 2019, recorded in Volume 762, Page 153, Official Public Records of said County, same being on the intersection of the East right-of-way line of County Road No. 2380 and the South right-of-way line of F. M. Highway No. 195;

Thence South 88° 02' 13" East, along the Northernmost NBL of said 200 acre tract and the South right-of-way line of said F. M. Highway No. 195, for a distance of 493.71 feet to a wood right-of-way monument found on the beginning of a curve to the left;

Thence in a Northeasterly direction along the Northernmost NBL of said 200 acre tract and the South right-ofway line of said F. M. Highway No. 195 and said curve to the left having a chord which bears North 88° 07' 43" East - 751.45 feet, a radius of 5769.58 feet, and a arc length of 751.98 feet to a 1/2 inch iron rod capped "JMN 4025" found at the end of said curve to the left:
