

### LAND DESCRIPTIONS

### TRACT 1

A PART OF THE NORTHEAST QUARTER OF THE NORTHEAST QUARTER (NE/4 NE/4) OF SECTION FIFTEEN (15), TOWNSHIP SIXTEEN (16) NORTH, RANGE SIXTEEN (16) WEST OF THE FIFTH PRINCIPAL MERIDIAN, SEARCY COUNTY, ARKANSAS AND BEING MORE PARTICULARLY DESCRIBED AS FOLLOWS:

COMMENCING AT AN EXISTING ONE-HALF INCH REBAR MARKING THE NORTHEAST CORNER OF THE NE/4 NE/4 OF SAID SECTION 15, SAID POINT ALSO BEING THE POINT OF BEGINNING OF TRACT BEING DESCRIBED, THENCE SOUTH 01° 50′ 53″ WEST (BEARINGS BASED ON GRID NORTH NAD 83) 1350.84 FEET (DISTANCES ARE GROUND DISTANCE) TO AN EXISTING ONE-HALF INCH REBAR MARKING THE SOUTHEAST CORNER OF SAID NE/4 NE/4, THENCE ALONG THE SOUTH LINE OF SAID NE/4 NE/4 NORTH 89° 22′ 52″ WEST 1043.33 FEET TO A POINT IN THE CENTERLINE OF SANDERS FIELD ROAD, THENCE LEAVING SAID SOUTH LINE AND ALONG SAID CENTERLINE THE FOLLOWING COURSES: NORTH 25° 35′ 07″ EAST 49.92 FEET, NORTH 88° 34′ 31″ EAST 120.56 FEET, NORTH 39° 31′ 35″ EAST 106.89 FEET, NORTH 38° 08′ 28″ EAST 112.70.00 FEET, NORTH 62° 19′ 28″ EAST 162.28 FEET, NORTH 44° 10′ 53″ EAST 73.29 FEET, NORTH 37° 22′ 30″ EAST 189.66 FEET, NORTH 31° 35′ 27″ EAST 97.55 FEET, NORTH 19° 25′ 32″ EAST 69.30 FEET, NORTH 00° 14′ 14″ EAST 65.31 FEET, NORTH 11° 14′ 14″ WEST 76.53 FEET, NORTH 14° 57′ 26″ WEST 9.52 FEET TO A POINT, THENCE LEAVING SAID CENTERLINE NORTH 89° 30′ 04″ WEST 937.81 FEET TO A POINT, THENCE NORTH 10° 36′ 40″ EAST 392.79 FEET TO AN EXISTING ONE-HALF INCH REBAR MARKING THE NORTHWEST CORNER OF SAID NE/4 NE/4, THENCE SOUTH 89° 30′ 04″ EAST 1330.83 FEET TO THE POINT OF BEGINNING, CONTAINING 26.13 ACRES, MORE OR LESS.
