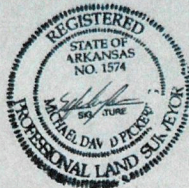

THENCE North 88 degrees 09 minutes 49 seconds West for a distance of 499.50 feet TO A #4 REBAR ON THE NORTH RIGHT OF WAY LINE OF HIGHWAY 1669 FOR THE POINT OF BEGINNING;
THENCE South 85 degrees 55 minutes 49 seconds West for a distance of 97.93 feet ALONG SAID RIGHT OF WAY LINE TO A 400 NAIL;
THENCE LEAVING SAID RIGHT OF WAY;
THENCE North 01 degrees 36 minutes 31 seconds West for a distance of 311.36 feet TO A #4 REBAR;
THENCE South 87 degrees 38 minutes 36 seconds East for a distance of 105.79 feet TO A #4 REBAR;
THENCE South 00 degrees 08 minutes 15 seconds East for a distance of 299.94 feet TO THE POINT OF BEGINNING.

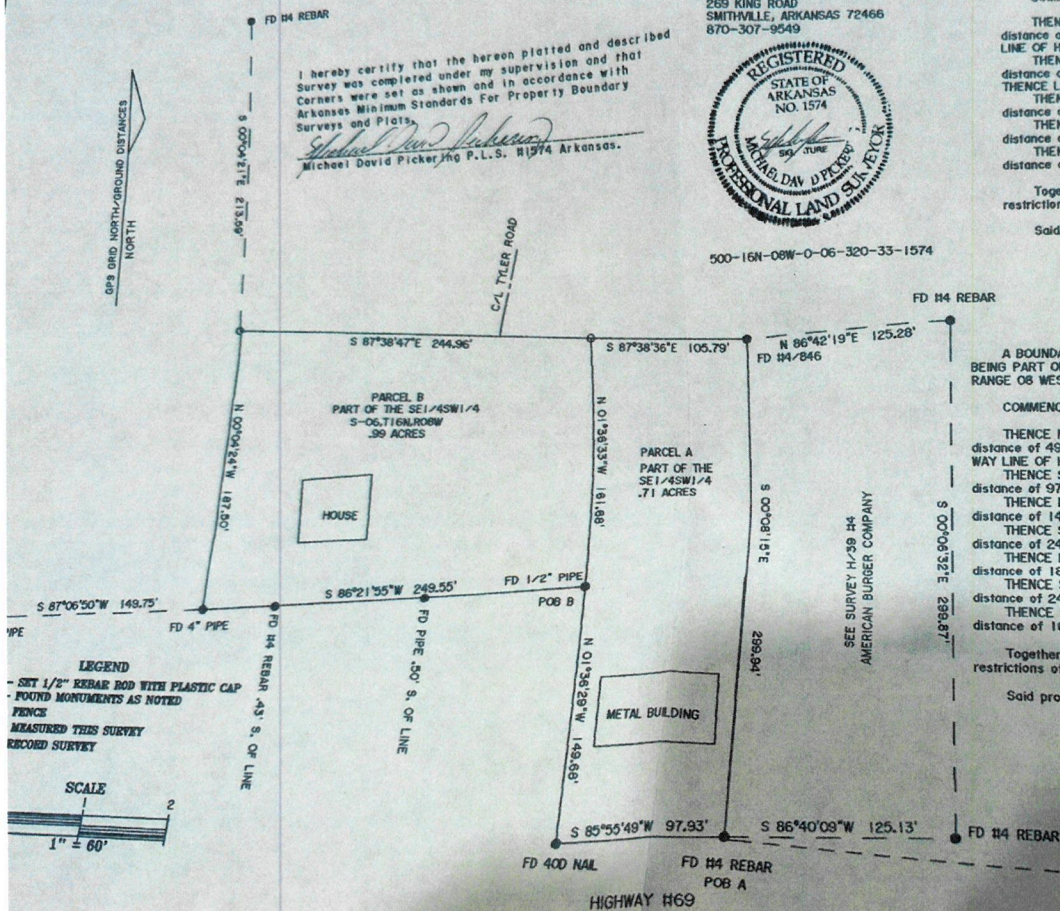

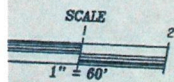

THENCE North 01 degrees 36 minutes 29 seconds West for a distance of 149.68 feet TO A 1/2" PIPE FOR THE POINT OF BEGINNING;
THENCE South 86 degrees 21 minutes 55 seconds West for a distance of 249.55 feet TO A 4" PIPE;
THENCE North 00 degrees 04 minutes 24 seconds West for a distance of 187.50 feet TO A #4 REBAR;
THENCE South 87 degrees 38 minutes 47 seconds East for a distance of 244.96 feet TO A #4 REBAR;
