

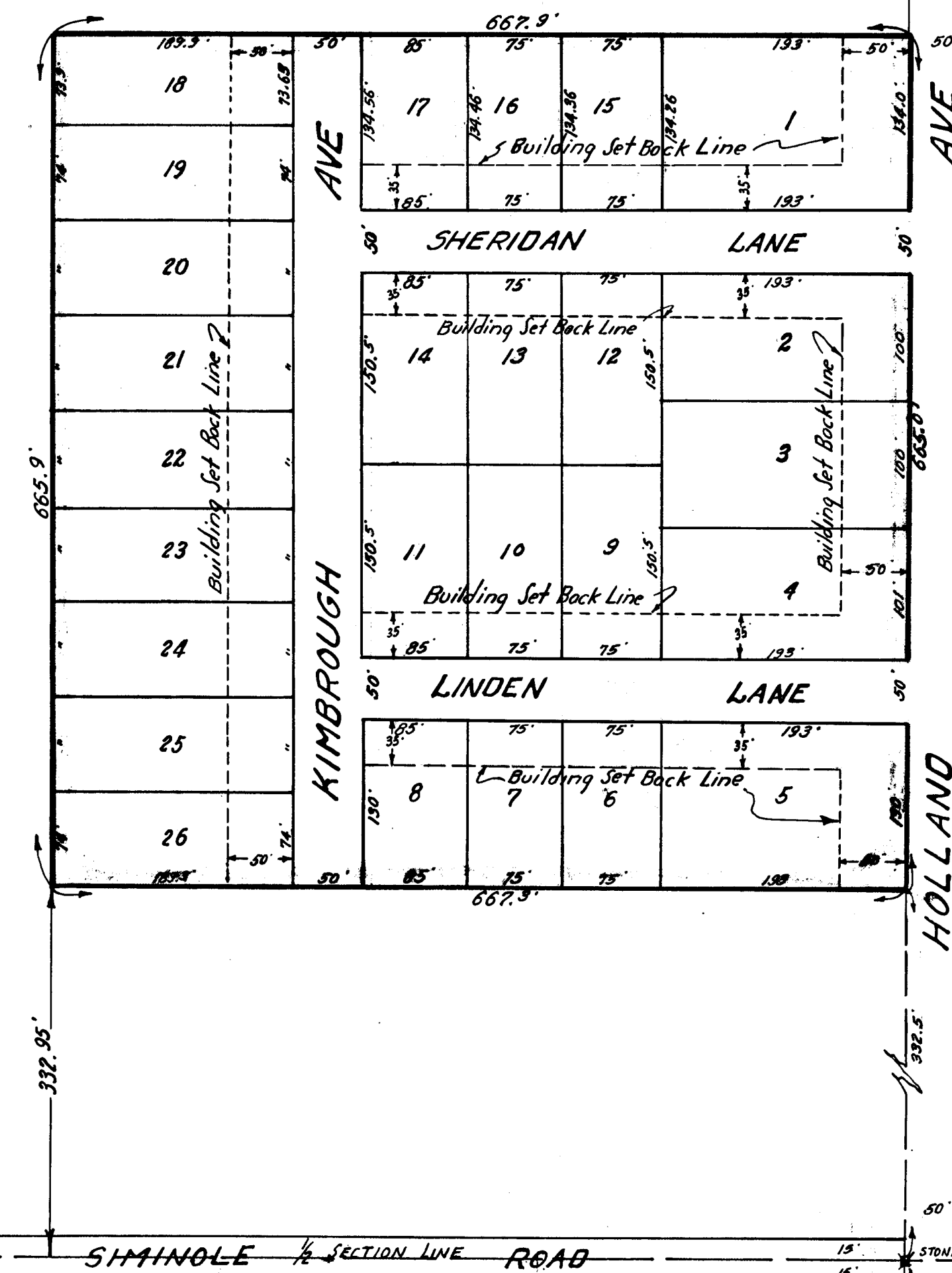

DESCRIPTION

THE PLAT OF HEDGEWOOD PLACE, COMPRISES THE FOLLOWING, THE S.E. 1/4 OF THE N.W. 1/4 OF THE N.W. 1/4 OF SECTION 36, T-29-N, R-22-W, AND THE N.W. 1/4 OF THESE 1/4 OF THESE 1/4 OF THE N.W. 1/4 OF SECTION 36, T-29-N, R-22-W, DESCRIBED AS - BEGINNING AT THE S.E. CORNER OF N.W. 1/4 OF SECTION 36, T-29-N, R-22-W, THENCE NORTH 83.25° THENCE WEST 667.3' THENCE NORTH 66.5° THENCE EAST 667.3' THENCE SOUTH 66.5° TO THE PLACE OF BEGINNING, ALL IN GREENE COUNTY MISSOURI.

SAID LAND HAS BEEN SUB-DIVIDED AS SHOWN ON PLAT. THE LOTS AND STREETS ARE MARKED IN FEET AND TENTHS OF FEET. STREETS ARE HEREBY DEDICATED TO THE PUBLIC.

BUILDING SET BACK LINES TO BE, AS SHOWN ON THIS PLAT 50' ON KIMBROUGH AVE, 50' ON HOLLAND AVE, 35' ON DEDICATED 50' STREETS.
