

Alabama REALTORS® 2025 REFERRAL AGREEMENT

Legal Disclaimer: This agreement is for use when referring a consumer looking to sell, purchase, or rent real estate in Alabama. Alabama law requires Alabama real estate licensees to receive all funds earned from real estate transactions from the licensee's qualifying broker. Alabama law prohibits licensees from paying a referral fee to anyone who does not hold an active real estate license. If the referring agent's license terminates or becomes inactive during the term of this Agreement, the referring agent may be prohibited from earning a referral fee.
