Thence North 87 degrees 44 minutes 13 seconds West, along the S.B.L. of said tract and the centerline of said Road for a distance of 425.43 feet to a Railroad Spike found for corner;

Thence North 83 degrees 04 minutes 15 seconds West, continuing along said lines for a distance of 195.56 feet to a Railroad Spike found for corner at the S.W.C. of said tract and the S.E.C. of a called 8.463 acres (Vol 2154 Pg 315);

Thence North 01 degrees 28 minutes 08 seconds East, along the E.B.L. of said called 8.463 acres for a distance of 460.85 feet to 1 Inch Iron found for corner at the N.E.C. of said called 8.463 acres;

Thence North 00 degrees 51 minutes 29 seconds West, along the occupied W.B.L. of said tract and the occupied E.B.L. of a called 40.8 acres (Vol 1795 Pg 13) for a distance of 972.95 feet to a Fence Corner, at the S.E.C. of a called 10.243 acres (Vol 1278 Pg 471);

Thence North 03 degrees 00 minutes 59 seconds East, along the W.B.L. of said tract and the E.B.L. of a called 10.243 acres (Vol 1278 Pg 471) for a distance of 233.12 feet to Nail set for corner, at a fence corner;

Thence North 66 degrees 10 minutes 48 seconds East, along the S.E.B.L. of that certain tract (Vol 953 Pg 497) for a distance of 314.71 feet to a ½ Inch Iron Rod set for corner, from which an Axle found for corner at the S.E.C. of said tract (Vol 953 Pg 497) bears North 66 degrees 10 minutes 48 seconds East, 191.58 feet;

Thence South 89 degrees 07 minutes 59 seconds East, along the N.B.L. of said tracts and the S.B.L. of that certain tract (Vol 1367 Pg 98) for a distance of 308.68 feet to a 1/2 Inch Iron Rod found;

Thence North 88 degrees 53 minutes 44 seconds East, continuing along said lines for a distance of 130.95 feet to a 1/2 Inch Iron Rod found for corner at the N.E.C. of said tract and the N.W.C. of said called 25.604 acres;

Thence South 89 degrees 58 minutes 09 seconds East, continuing along the N.B.L. of said called 25.604 acres and the S.B.L. of said tract (Vol 1367 Pg 98) at 547.63 feet pass a 1/2 Inch Iron Rod found for reference and continue for a total distance of 647.03 feet to a Point for Corner in a swamp at the N.E.C. of said tract;

Thence South 00 degrees 38 minutes 23 seconds West, along the E.B.L. of said tract and the W.B.L. of said called 26.00 acres for a distance of 1558.42 feet to a 5/8 Inch Iron Rod found for corner at the N.E.C. of a called 1.227 acres (2014-00004867);

Thence North 89 degrees 20 minutes 37 seconds West, along the N.B.L. of said called 1.227 acres for a distance of 208.54 feet to a 4" Steel Fence Corner at the N.W.C. of said called 1.227 acres;

Thence South 00 degrees 27 minutes 50 seconds West, along the W.B.L. of said called 1.227 acres for a distance of 203.96 feet to a 1" Flat Iron found at corner;

Thence South 11 degrees 33 minutes 23 seconds West, continuing along the W.B.L. of said called 1.227 acres for a distance of 56.57 feet to a Railroad Spike found for corner at the S.W.C. of said called 1.227 acres;

Thence South 87 degrees 22 minutes 18 seconds West, along the S.B.L. of said tract and the centerline of said C.R. # 3234 for a distance of 395.37 feet to the place of beginning containing 50.0580 acres of which 0.6901 acres lies in the R.O.W. of said Road.
