FIRST TRACT:

Said 272.33 acres of land contains 0.50 acres, more or less, which lies in a public road, leaving a net acreage of 271.83 acres. Said 272.33 acres of land is a part of that land described in a deed from Kathleen Shoemake to land is a part of the leed Records of San Saba County, Texas.

BEGINNING at a ½" iron pin (set) and corner post in the north line of Survey #77, as fenced, the same being the most northerly northeast corner of a 30.43 acre tract of land and the most northerly northwest corner of this tract. Said corner lies S 78° 06' E 1,100.3 feet from the northwest corner of said Survey #77.

THENCE S 78° 04' E 1,562.5 feet along the general course of a fence to a 2" iron pin (set) and cedar post.

THENCE S 77° 20' E 101.6 feet along said fence to a ½" iron pin (set) and cedar post.
