

LEAD-BASED PAINT DISCLOSURE

- Federal law mandates that Sellers of housing constructed prior to 1978 must complete certain Lead-Based Paint 1 2 Disclosure requirements. These should be completed before the Buver makes an offer and certainly before the Seller
- 3 accepts a purchase offer, otherwise the Buyer may not be obligated under any agreement to purchase such housing.

- 5 Every purchaser of any interest in residential real property on which a residential dwelling was built prior to 1978 is 6 notified that such property may present exposure to lead from lead-based paint that may place young children at risk of 7 developing lead poisoning. Lead poisoning in young children may produce permanent neurological damage, including learning disabilities, reduced intelligence quotient, behavioral problems, and impaired memory. Lead poisoning also 8 9 poses a particular risk to pregnant women. The Seller of any interest in residential real property is required to provide
- 10 the Buyer with any information on lead-based paint hazards from risk assessments or inspections in the Seller's
