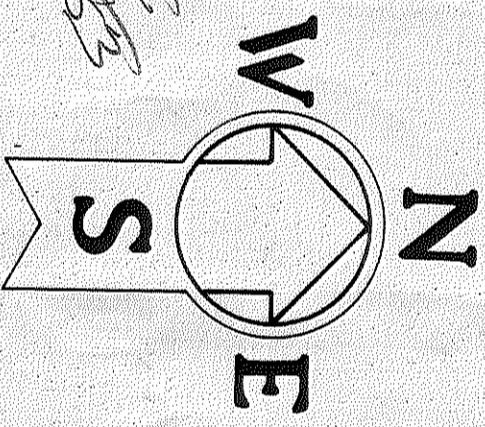
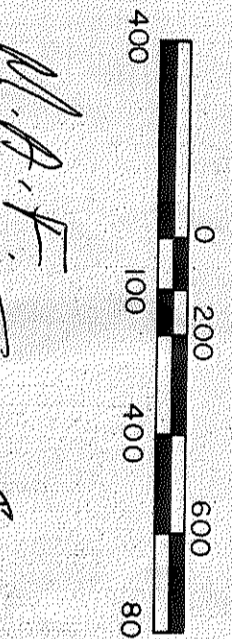

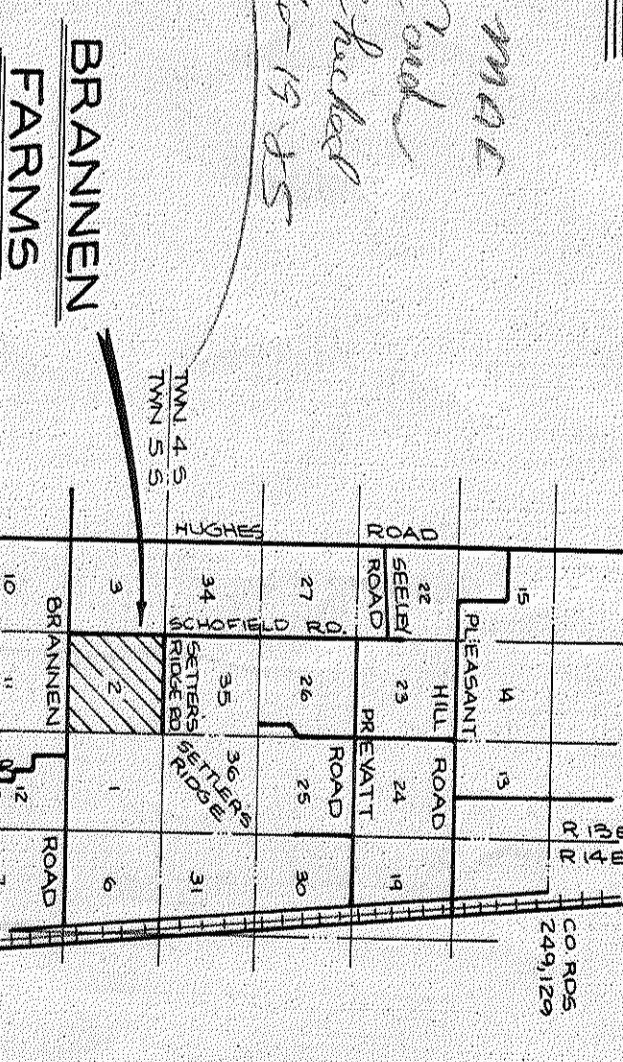

GRAPHIC SCALE: 1" = 400'

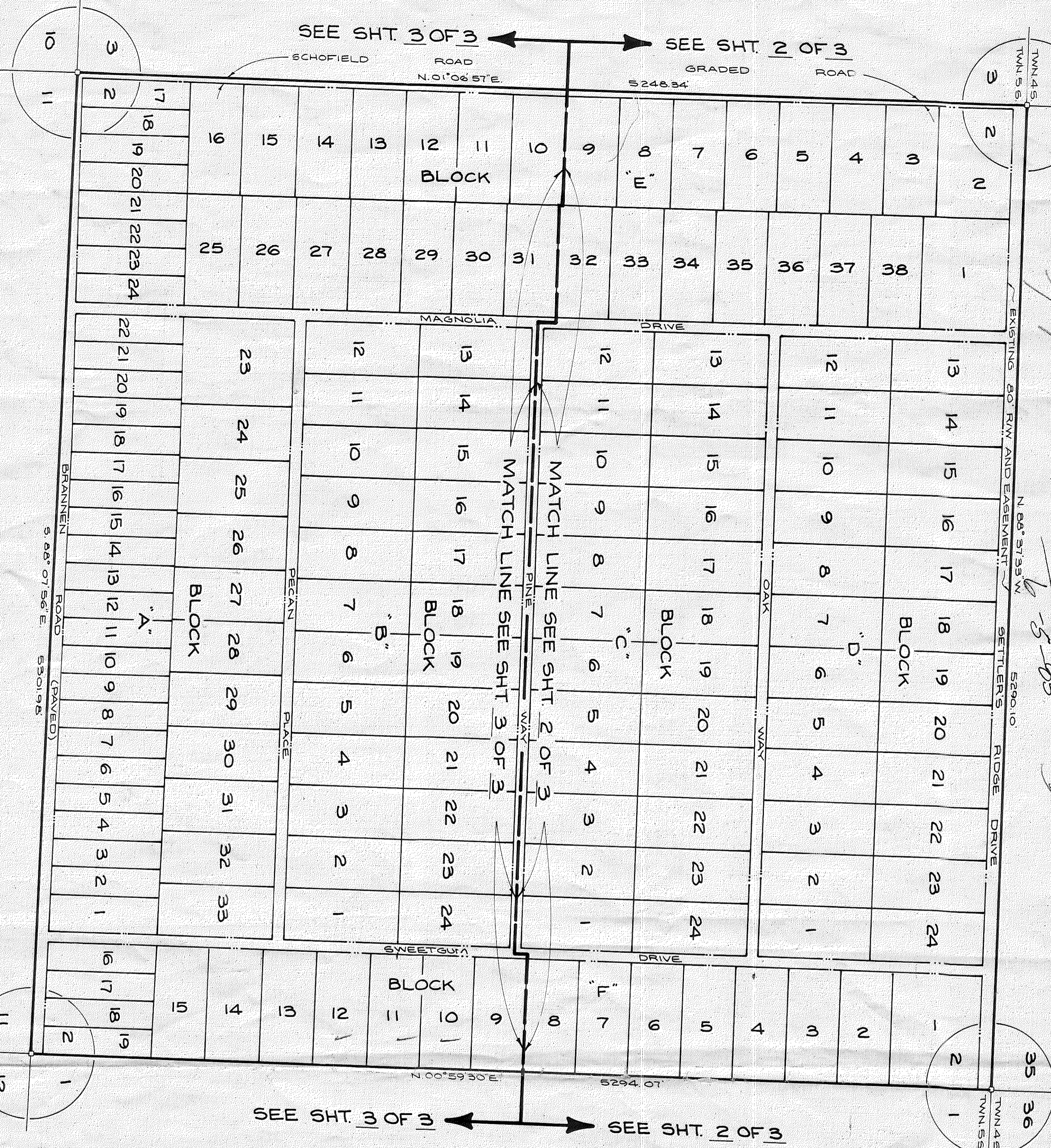
