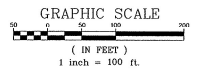
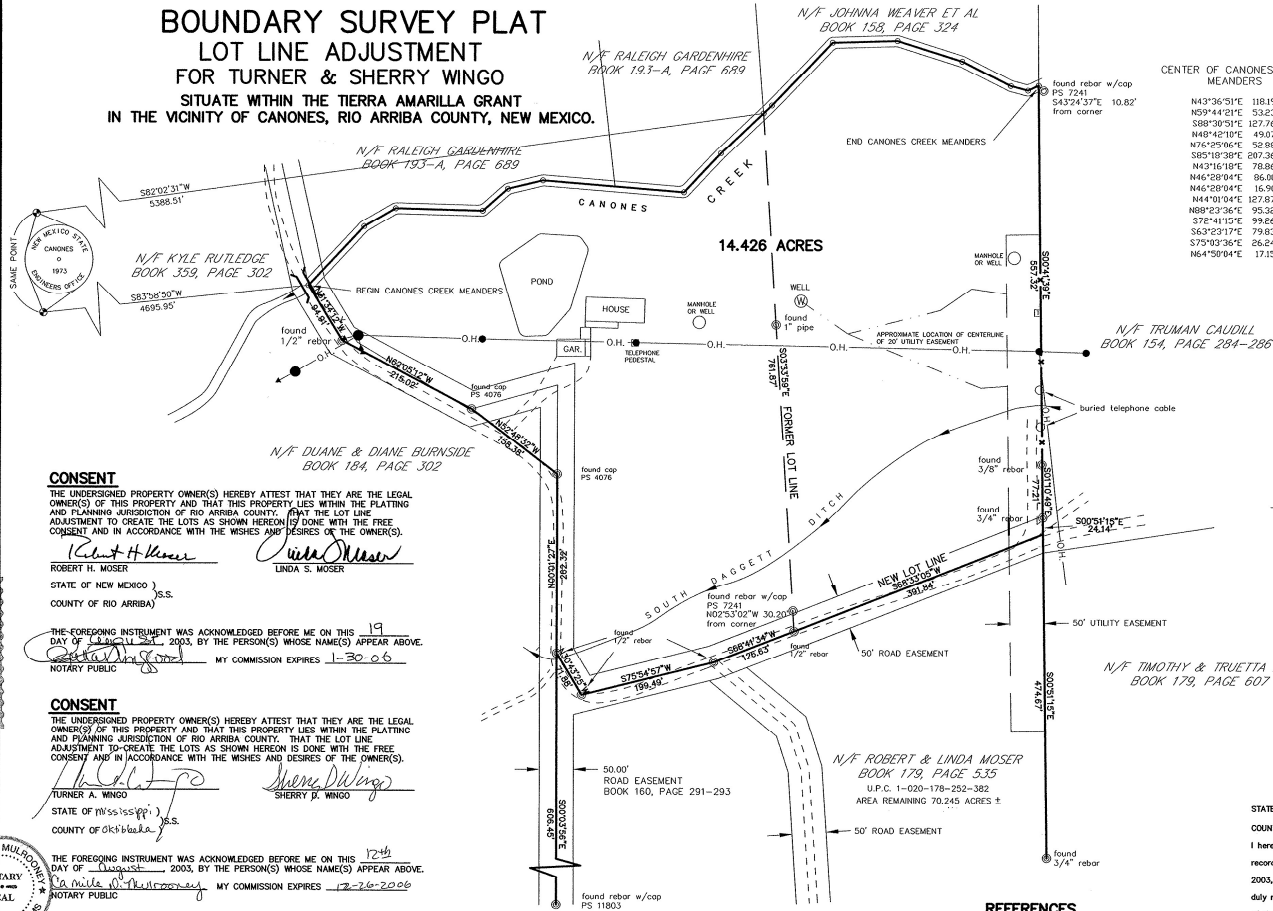


BOUNDARY SURVEY PLAT
