The septic system lines need to be on contour and placed on lot 13. Lot 14 is unsuitable due to topography. The property line between lots 13 & 14 will need to be vacated and recorded. The site plan is required is to prove that all setbacks can be met. If setbacks cannot be met, the proposed lot shall be deemed unsuitable due to lack of available space.

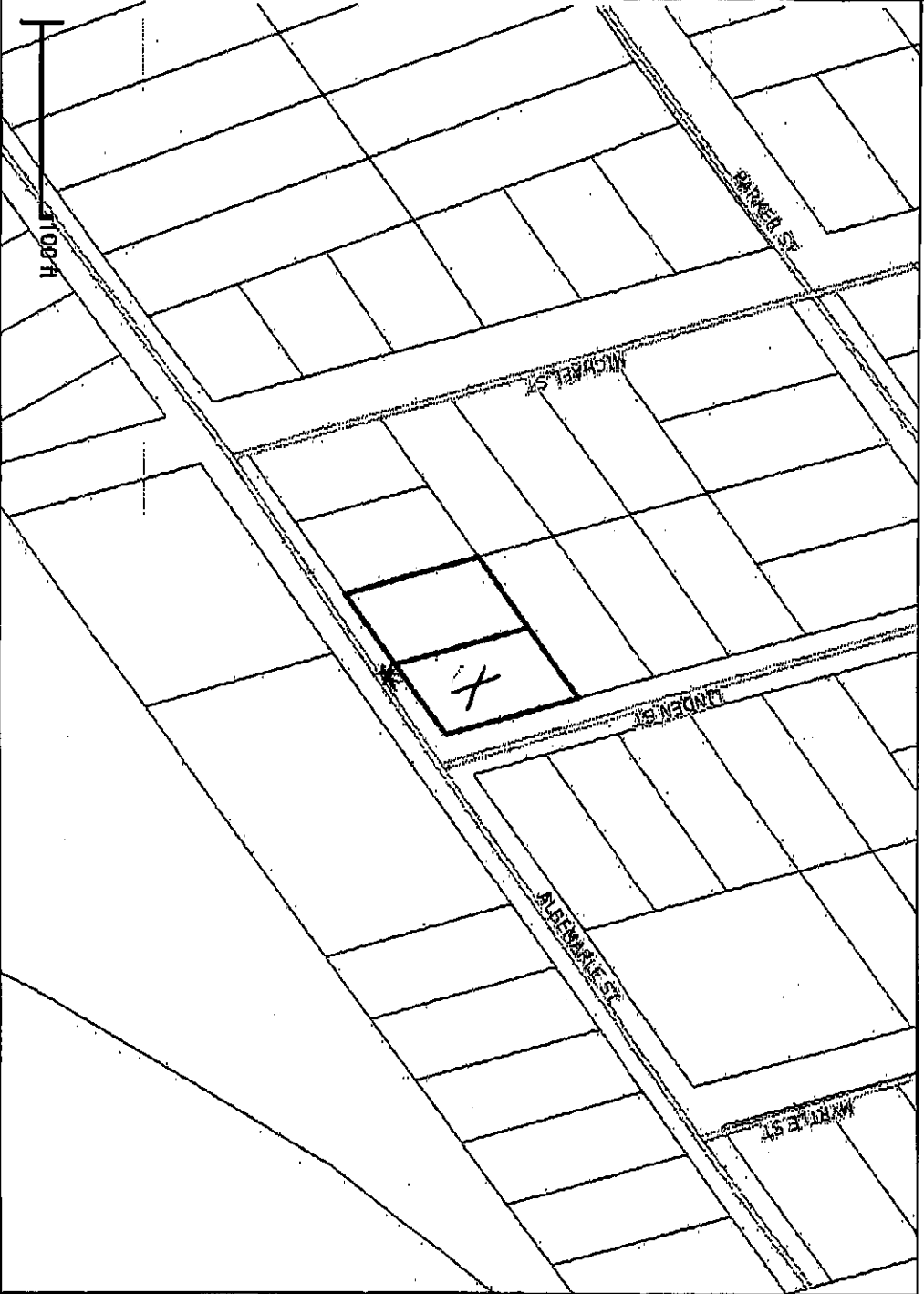
